

# **Directions to Salka Law LLC**

#### From Route 17 North or Route 17 South

Take Route 17 to Route 4 East. Travel for 2.5 miles and then take the right lane "Hackensack Ave/Hackensack South" ramp. Merge onto Hackensack Avenue. At second light, turn left onto Temple Avenue. One University Plaza is the first building on your left. Salka Law LLC is located on the fifth floor, Suite 516.

### From Garden State Parkway (From Points North)

Take Garden State Parkway South to Exit 163 (Route 17 South exit). Stay in the two right lanes of Route 17 South for the Route 4 East exit, "Fort Lee, New York." Bear left on ramp to proceed to Route 4 East. Travel on Route 4 East for 2.5 miles and then take the right lane "Hackensack Ave/Hackensack South" ramp. Merge onto Hackensack Avenue. At second light, turn left onto Temple Avenue. One University Plaza is the first building on your left. Salka Law LLC is located on the fifth floor. Suite 516.

### From Garden State Parkway (From Points South)

Take Garden State Parkway North to Exit 161 (Route 4 East). Merge onto Route 4 East. Travel on Route 4 East for 2.5 miles and then take the right lane "Hackensack Ave/Hackensack South" ramp. Merge onto Hackensack Avenue. At second light, turn left onto Temple Avenue. One University Plaza is the first building on your left. Salka Law LLC is located on the fifth floor, Suite 516.

## From New Jersey Turnpike (From Points South)

Take New Jersey Turnpike North (I-95N) and follow signs to George Washington Bridge. Use left two lanes and merge onto Route 80 West. Then, use the left two lanes to merge onto Route 80 West towards Hackensack. Take Exit 66, "Hudson Street/Hackensack/Little Ferry." Merge onto East Kennedy Street. Turn left onto South River Street. South River Street briefly turns into Hackensack Avenue. Turn right onto Temple Avenue. One University Plaza is the first building on your left. Salka Law LLC is located on the fifth floor, Suite 516.

### From Route 80 (From Points East)

Take Route 80 West to Exit 66, "Hudson Street/Hackensack/Little Ferry." Merge onto East Kennedy Street. Turn left onto South River Street. South River Street briefly turns into Hackensack Avenue. Turn right onto Temple Avenue. One University Plaza is the first building on your left. Salka Law LLC is located on the fifth floor, Suite 516.

### From Route 80 (From Points West)

Take Route 80 East towards Paterson/New York. Take the right lane Exit 62A-62B toward Saddle Brook/Saddle River Rd/Garden State Pkwy. Keep right to stay on Exit 62A, then keep left at the fork to merge onto Garden State Parkway North. Pay toll, briefly take Garden State Parkway North to Exit 161 (Route 4 East). Merge onto Route 4 East. Travel on Route 4 East for 2.5 miles and then take the right lane "Hackensack Ave/Hackensack South" ramp. Merge onto Hackensack Avenue. At second light, turn left onto Temple Avenue. One University Plaza is the first building on your left. Salka Law LLC is located on the fifth floor, Suite 516.

## From New York Via The George Washington Bridge

Take the George Washington Bridge to Route 4 West. Take Route 4 West 3.5 miles. Pass Riverside Square Mall, go under the overpass, and take the exit, "Hackensack Avenue-Hackensack." Merge onto Hackensack Avenue. In approximately one mile, at second light, turn left onto Temple Avenue. One University Plaza is the first building on your left. Salka Law LLC is located on the fifth floor, Suite 516.

# From New York Via The Lincoln Tunnel

Take the Lincoln Tunnel to Route 495 West. Use the right 2 lanes to take New Jersey Turnpike North (I-95N) for approximately 3 miles. Then, use the left two lanes to merge onto Route 80 West towards Hackensack. Take Exit 66, "Hudson Street/Hackensack/Little Ferry." Merge onto East Kennedy Street. Turn left onto South River Street. South River Street briefly turns into Hackensack Avenue. Turn right onto Temple Avenue. One University Plaza is the first building on your left. Salka Law LLC is located on the fifth floor, Suite 516.
